Copyright

Takedown

The SAS-Space takedown policy is as follows:

"Complaint about the content of any item on SAS-Space should first be made by email or by post to the <u>SAS-Space Manager</u>. If an Out-of-Office reply is received, the complaint should be passed to the member of SAS staff named in that reply.

If the complaint is deemed to be genuinely made, then the full-text file of the item will be removed from public view by the end of the working day following that on which the complaint was received. The metadata record will not be altered at this stage. This removal should not be construed as having any bearing on the validity or otherwise of the complaint.

Enquiries will be made as to the validity of the complaint, and a decision made as to whether the item should be permanently hidden from public view or re-exposed. This decision will be made with recourse in all cases to the Digital Resources and Strategy Committee of the School of Advanced Study. If it is permanently removed, the metadata record will remain visible, but will be amended to reflect the fact of the removal."

Acknowledgement

An acknowledgement is a general statement giving credit to the source and distributor and includes copyright information. It can be given at the start of, or within, the text, or at the end of the article before the bibliographic references/citations. You can find the appropriate details for specific materials in the bibliographic records.

Acknowledgement of Senate House Library must be made for this permission to reproduce the work/s, in the form, Senate House Library, University of London, with the appropriate citation to the document reproduced. Please acknowledge the collection as follows:

"The materials used in this article are part of the Ruth First Papers, held by the Institute of Commonwealth Studies library, Senate House Library, University of London, ref. 1CS117. The material is under copyright."

Citation

As well as general bibliographic information, a citation should include:

- A reference for a specific object in the collection. The code for the collection is ICS117, and the object codes begin "RF/#/#" so a reference to a specific item would be, for example: "ICS117/RF/2/6"
- The name of the collection, "Ruth First Papers"
- The name of the publisher: "Institute of Commonwealth Studies Library, Senate House Library, University of London"

A citation is more formal than an acknowledgement. It follows a standard format and should include enough information so that the exact version of the data being cited can be located. New standards for citing data are emerging, and will depend on the preferred style of the journal or publisher. The UK Data Archive has published some-helpful quidance on citing data.
